We have reviewed the accompanying statement of unaudited financial results of **Shree Ram Twistes Limited** (the "Company") for the quarter ended December 31, 2025 and the year-to-date results for the period 01 April 2025 to 31 December 2025 (the "Statement") attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended) ("Listing Regulations").
